## **FINALISATION OF SHARE PURCHASE PLAN AND APPENDIX 3B**

Aurora Oil & Gas Limited (ASX:AUT) ("Company" or "Aurora") advises that the Share Purchase Plan announced on 18 June 2010 ("SPP") has been finalised and 8 million new fully paid ordinary shares have now been allotted and issued to raise \$6 million.

The SPP was significantly oversubscribed. As a result, the directors of Aurora have determined that a pro rata scale back of 32.75% will be applied to eligible applications.

All subscription monies received in excess of the allocation amount (being the number of shares actually allotted multiplied by the issue price) will be refunded by cheque by the end of the week.

A completed Appendix 3B in respect of the Share Purchase Plan Shares is attached and the Company expects that holding statements will be despatched to shareholders by the beginning of next week.
